

SPEED RADAR SIGN

The speed radar sign is set up at the entrance of the community on Highway #25, as we have had a significant amount of speed violations over the past number of months in that area. Remember that the speed limit as you enter the community is 50 km/h. 70% of vehicles were violating the speed limit in that area, this month.

Please drive within the posted speed limits (40 km/h) on all municipal streets. Thank you for your cooperation.

MUNICIPAL WATER & SEWER UTILITY RATE INCREASES FOR 2025

The Village of St. Louis will be increasing the rates charged for water and sewer service for 2025, in accordance with the municipal waterworks rate schedule approved in 2016. The basic rate for 5,000 gallons of usage in a three month invoicing period will increase to \$135.00 per quarter (a \$1.67/month increase over 2024). Residential & Commercial sewer rates for 2025 will remain at \$70 & \$115 per quarter, respectively with no increase. The per 1,000 gallon price charged to consumers, who use over the 5,000 gallon minimum in a three month period, will increase for 2025 to \$22.73 per 1,000 gallons.

The quarterly infrastructure fee charged on all accounts will remain at \$50 per quarter. This fee is collected and used to help offset future capital repair and replacement of the waterworks infrastructure. Residential customers can expect minimum use (under 5,000 gallons) invoices to be at \$306.00 per quarterly invoice. Average households that use around 10,000 to 12,000 gallons in a month can expect quarterly invoices of around \$420.00 to \$465.00. Commercial customers will see minimum quarterly invoices of \$351.00.

These quarterly utility invoices will continue to include water usage fees, sewer fees, infrastructure fees and all monthly waste/recycle collection and disposal fees. The new rates will be reflected on all March 2025 utility invoices and are necessary due to increased operational costs of water and sewer facilities and infrastructure.

The Provincial government regulates and approves all water and sewer utility rates for municipalities to ensure that the utility is self-sufficient and does not rely on other municipal funding sources, including taxation and general revenues to cover water and sewer operating and capital expenses. These expenses must all be covered with revenue generated by the water and sewer rate structure to consumers.

Also, please note that water and sewer accounts are due when rendered and if rates remain unpaid after 20 days from the date of mailing that the Village has the right to discontinue service without notice and a fee of \$10.00 will be charged for re-connection. The Village does not currently charge interest on past due accounts but is looking at this as a future option. Unpaid utility accounts can be added to taxes on a property and collected through tax enforcement procedures, if required. These are not options that the Village wishes to explore, so it is asked that all consumers please keep their accounts current. The Village is not in a financial position to carry outstanding balances on accounts for customers.

COMMUNITY CARE

St. Louis Village Council would like to remind residents that the care and upkeep of our community is a continuous year-round process. Residents are asked to ensure that:

- All trees/hedges/shrubs/branches are contained within property boundaries to ensure the pedestrian lanes on sidewalks are free and that there is not any encroachment onto driving portions of streets and alleyways. This helps facilitate municipal maintenance efforts for both grass cutting and snow removal.
 - All waste is properly disposed of and not allowed to accumulate on their property.
 - All pets are kept under control and not allowed to roam freely off their property.
- All dogs are cleaned up after, while being walked on municipal streets, parks and property not that of the owner.
 - Municipal traffic signs and speed limits are adhered to.
- On street boulevard area parking is done parallel to the driving portion of the street and in the same direction as traffic flow. No angle parking.

DEVELOPMENT & BUILDING PERMIT REQUIREMENTS

The Village of St. Louis requires property owners or contractors to obtain a Development Permit and a separate Building Permit when considering any type of development or construction on any residential, commercial/industrial or agricultural lot within the Village of St. Louis municipal limits. Each of these permits is subject to various fees, depending on the nature of the project.

The Development Permit ensures that all regulations contained within the Village of St. Louis Zoning Bylaw and Amendments are met before any development or construction can occur.

The Building permit ensures that all construction is carried out in accordance with the Village of St. Louis Building Bylaw and all applicable current National Building Codes and Provincial Legislation.

A Development Permit & Building Permit ARE required for:

- 1. Residential Dwellings single or multi-family;
- 2. Commercial/Industrial or Agricultural Buildings;
- 3. Additions to Residential Dwellings;
- 4. Additions to Commercial/Industrial or Agricultural Buildings;
- 5. Residential Basement Development rec. rooms, bedrooms, bathrooms, etc.;
- 6. Any Structural Modification to a Residential Dwelling single or multi-family; or any Structural Modifications to a Commercial/Industrial or Agricultural building;
- 7. Attached Garages or Carports;
- 8. Detached Garages or Carports;
- 9. Storage Sheds in excess of 100 square feet in area;
- 10. Decks, Exterior Stairs and Landings, Wheelchair Ramps;
- 11. Fireplaces
- 12. Fences restrictions on height and location do apply

A Development Permit & Building Permit <u>ARE NOT</u> required for the following uses, provided all other provisions and regulations of the Village of St. Louis Zoning Bylaw and Amendments & Building Bylaw are complied with:

- 1. Storage or Accessory buildings under 100 square feet in area;
- 2. Sidewalks on private property only;
- 3. Replacement of most existing building components that do not include structural alterations, including:
 - a) shingles
 - b) doors and windows, if sizes remain as original
 - c) siding, stucco, brick veneer
 - d) kitchen cabinets
 - e) gyproc wall finishes
 - f) painting, wallpapering
 - g) carpet, linoleum;

NOTE:

• For sewer and water installations, replacements, a separate Plumbing Permit may be required.

New legislation in the form of *The Construction Codes Act* (CCA) and subsequent *Building Code Regulations*, *Energy Code Regulations* and *Plumbing Code Regulations* came into force in 2022 and the municipal Building Official, B & B Enforcement is responsible for enforcing these regulations within our municipality. Failure to obtain proper permitting prior to commencing work could result in additional costs, project delays and unwanted amendments to your project.

DO NOT PRUNE ELM TREES APRIL I—AUGUST 31 EACH YEAR

To reduce the risk of Dutch elm disease, pruning of elm trees is prohibited throughout Saskatchewan each year from April 1 until August 31. Fresh cuts from pruning attract the beetles that can spread the disease, increasing the chance of an infection. Pruning remains an important part of regular elm tree care and is encouraged, before and after the annual ban period. Proper pruning helps keep trees healthy and better able to resist disease. The removal of dead and dying elm wood through pruning also helps to reduce beetle breeding habitat and control the beetle population. Prompt and proper disposal of the pruned wood is also essential to keep Dutch elm disease from spreading.

Provincial regulations also require commercial pruners of elm trees to have taken a recognized training program or be under the supervision of someone who has. Improper pruning techniques can contribute to the spread of many tree diseases, including Dutch elm disease.

2025 DOG LICENSES NOW AVAILABLE

In accordance with the Municipal Dog Bylaw 02/20, all dogs that are kept within the Village limits are required to be licensed annually. 2025 dog tag licenses are now available at the Village Office. Please ensure to license your dog for the upcoming year.

License fees are as follows: All dogs \$10.00/year

Also, please note that when licensing your pet for the first time with the Village Office you will be required to complete a Dog License Application Form for Village records. Any person who licensed their dog in previous years will not be required to fill in this application as the information will already be in the database.

Also, please remember to clean up after your dog when walking them and do not allow them out to defecate on other property. This is an offence punishable by fine, in accordance with the Municipal Bylaw. Common courtesy and respect for others' property is expected of all pet owners.

LOUIS .- More than 300 peo ple gathered in the Grain Growers' hall Monday evening, January 24, to honor Mr. and Mrs. Antoine Dubray, pioneer residents of the St. Louis district on the occasion of their golden wedding, Mr. and Mrs. Dubray's six children, including their three sons, Martin, Frederick and Ernest (Bud), and three daughters, Mrs. Wilson, Mrs. J. A. Sinclair and Mrs. F. Banks, were all present. The evening was spent in dancing with a short program and a presentation following a midnight supper.

The hall was appropriately decorated with purple, gold and green The dancing opened streamers. with an oldtime waltz danced by the bride and groom, later other other members of the family and

friends joined them.

For the midnight supper a long table was placed across the front of the hall. The honored guests and a number of their old friends were seated at the table. The table was decorated with artificial flowers and house plants. A four-tier wedding cake occupied a prominent place on this table.

S. A. Marvin presented Mr. and Mrs. Dubray with a purse from the community as a small token of the esteem in which they are held. Mr. Marvin commented on the fact that Mr. and Mrs. Dubray were married in the old log church at Halcro, since replaced with a frame building. He said that Mr. Dubray had resided in the community for nearly 65 years. He said that it had been his duty to make presentations at gatherings, but generally to bid the guest of honor a safe journey and a happy landing, but he was glad to say that this time the guests were remaining in the district.
