<u>AED Advantage</u> – Defibrillator at River's Edge Care Home has pads expiring in June 2025. Replacement pads quote is \$572.80, same as for the Skating Rink unit that were recently replaced.

Cost is \$750 plus taxes.

Ministry of Government Relations – Notice that the Ministry is cleaning up some obsolete private Acts and one that exempts taxation on Parcels H & J in St. Louis for the Corporation Episcopale

Catholique Romaine de Prince Albert is no longer required and will be repealed, as they no longer own the property mentioned.

<u>First National Financial</u>—Would like to pay tax accounts via EFT and require banking information from the Village to proceed. Council needs to authorize submitting this information to them.

<u>Xylem</u> – Sewage lift stations inspection and servicing report. They recommend replacing all galvanized pump chains with stainless steel as they are beginning to corrode and are in danger of breaking when pumps are lifted, causing damage to pumps and loss of service on lift station. Quote to replace will be approximately \$4,000 and can be budgeted from water and sewer infrastructure funds. Once replaced with stainless steel, should last a lifetime.
