Introduction

The purpose of this memo is to provide you with a guideline as to the key dates and procedures you must take between now and Election Day, as well as some of your duties and responsibilities as a Candidate.

Candidate's Qualifications

- At least 18 years of age on Election Day
- Canadian citizen on Election Day
- Resident of Saskatchewan for at least 6 months on Election Day
- Resident of the Village for at least 3 months on Election Day

Elector's Qualifications

- At least 18 years of age on Election Day
- Canadian citizen on Election Day
- Resident of Saskatchewan for at least 6 months on Election Day
- And, either one of the following:
 - o Is a resident of the Village for at least 3 months on Election Day
 - Is the owner of assessable land within the Village for at least 3 months on Election Day

Nomination Papers

Nominations may be filed during working days from 9:00 AM – 4:30 PM, Thursday, September 19, 2024 until Tuesday, October 8, 2024 and on Wednesday, October 9, 2024 between the hours of 9:00 AM and 4:00 PM.

The nomination form has a front and back portion and candidates must ensure that the following has been entered:

- The candidate's name and civic street address (not mailing address) must appear on the front of the nomination form together with the office they are running for (Mayor or Councillor)
- Five (5) eligible electors who meet the qualifications noted above must sign the front of the form complete with civic street address or legal land description (not mailing address)
- The back of the form must show the name of the candidate, as it will appear on the ballot, as well as the office that they are running for

- The back of the form must be dated and signed by the candidate in the presence of two (2) witnesses
 - The witnesses do not have to be electors or residents of the community they must be of legal age (18 or older)

The candidate must also complete a Public Disclosure Statement as provided with the nomination form package. This statement must be completed in full and submitted with a completed Nomination Form.

Nomination Withdrawals

A candidate may withdraw his nomination by filing a written notice with the returning officer or the nomination officer any time after they have filed their nomination until 4:00 PM, Thursday October 10, 2024.

Advance Poll

An advance poll will be held at the St. Louis Community Hall on November 6, 2024 between the hours of 6:00 PM and 9:00 PM.

Election Day

Election Day is Wednesday, November 13, 2024 with the polls open from 9:00 AM until 8:00 PM. Voting will take place at the St. Louis Community Hall.

Candidate / Agents

All candidates and their agents may arrive or depart from the advance poll or the Election Day poll at any time from opening until closing of the polls. Any candidate and no more that two (2) of their agents may be present at any one time.

All candidates and their agents must register with the Deputy Returning Officer and sign a form when attending at the polls. Seating will be assigned at the polling place, from which to observe the vote.

Candidates or agents shall not:

- Question electors or attempt to influence their voting decision in any way
- Make their objection directly to the elector, if they object to that elector voting

 the objection must be made to the Deputy Returning Officer, after the ballot
 has been presented to the elector
- Attempt to determine how an elector has voted or will vote, or communicate to anyone how an elector has voted or will vote
- Canvass or solicit votes in, or within 100 metres of the polling place

At the counting of the ballots, only the candidate <u>or</u> one (1) agent may be present and they must be in the polling place prior to 8 PM.

Post Election Procedures

• Ballots will be counted and those elected will be determined on November 13, 2024

- Official results will be announced on November 14, 2024 at 10:00 AM
- The first Council meeting will be called by the Administrator likely to be held on November 27, 2024
- All elected candidates will receive written notice of the date, time and place of this meeting
- All elected candidates will be required to sign an oath and another public disclosure statement prior to assuming their duties

Advertising

Please ensure that each advertisement states who authorized the ad. If posters are being put up, please contact the Village Office to determine where they may be placed. Keep all campaign materials at least 100 metres from the St. Louis Community Hall (the polling place)

Persons Entitled to be in Polling Area

- Election officials
- Each candidate
- Not more that two authorized agents of a candidate
- Any person acting as an escort of a voter who is blind or otherwise incapacitated
- Elector waiting to cast his ballot
